PART 3 EXECUTION

3.1 INSPECTION

- A. Do not begin installation until substrates have been properly prepared.
- B. If substrate preparation is the responsibility of another installer, notify Architect of unsatisfactory preparation before proceeding.
- C. Verify proper power supply is available.

3.2 PREPARATION

- A. Clean surfaces thoroughly prior to installation.
- B. Prepare surfaces using the methods recommended by the manufacturer of the substrate for achieving the best result for the substrate under the project conditions.

3.3 INSTALLATION

- A. Install in accordance with manufacturer's instructions and requirements of authorities having jurisdiction.
- B. Use manufacturer's guidelines for minimum clearances to combustibles, walls, and finishes.
- C. Anchor all components firmly in position for long life under hard use.
- D. Upon completion of installation, visually inspect all exposed surfaces. Touch up scratches and abrasions with touch up paint recommended by the manufacturer; make imperfections invisible to the unaided eye from a distance of 5 feet (1.5 m).
- E. To use the mobile app, install it prior to your mobile device.
- F. Minimum Bottom Air intake 16 in² (100 cm²) is required. If the air inlet is concealed using a grille, the covered area must be compensated for by having a larger opening.
- G. Ensure that all electrical connections meet local electrical code requirements.

3.4 PROTECTION


- A. Protect installed products until completion of project.



Additional Fresh Air Inlets for Framed structure.

A CAUTION: Failure to include fresh air inlets will result in poor flame performance and damage to the fireplace. Fresh air inlets are required under the unit. If the air inlet is concealed using a grille, the covered area must be compensated for by having a larger opening.

The lower air inlet must allow for the air path to reach the underside of the unit. The opening must be a minimum of $16\ \text{in}^2$ ($100\ \text{cm}^2$).



Installation Opening

(existing hearth or framed construction)

Based on the product dimensions frame an opening or determine if product will fit in existing hearth.

This product can be built into a wall, surround or structure. Refer to the minimum opening dimensions below. Suitable clearance should be provided to allow air flow from the back and under the unit.

CAUTION: This fireplace is **NOT** load-bearing. Ensure the opening for the fireplace is framed in such a way that the weight of the building materials will not create pressure on the top of the fireplace.

CAUTION: Ensure air intake requirements are met. Failure to do so will result in poor flame performance and damage to the fireplace

NOTE: Wiring connections are located at the back of the firebox, in the bottom right corner.

Placement

I NOTE: Surfaces 12" (30 cm) above the fireplace will not exceed 40° C, as long as installation procedures are followed and heater inlet and outlet are not obstructed.

Installation in a Bathroom

If this unit is installed in a bathroom, it must be protected by a GFCI receptacle or circuit. If a receptacle is used, it must be readily accessible. This electrical appliance is NOT watertight. To prevent electric shock, it must be installed as to prevent water from entering unit, or installed away from showers, tubs, etc. Never locate fireplace where it may fall into a bathtub or other water container

Installation Recommendations for Overhanging Objects

For overhanging temperature-sensitive objects, such as a television, a mantel, or artwork, always follow the recommendations provided by its manufacturer for installation over a heater.
